## On the Right Track

Hope Center for Children's Empowering Families Program works with families to help them to reach their full potential. Elvia Gutierrez joined the Hope Center for Children staff as an Empowering Families caseworker last year and quickly saw what a large number of families in our community need help.

Through her work with families, Elvia met Sarah\*, a former client of the Empowering Families program. After moving out of town, Sarah's original caseworkers lost touch with her. During this time, Sarah was staying with friends in various unhealthy environments, and she was not attending school. Sarah experienced abuse and was coping with untreated mental health conditions. Upon returning to Spartanburg, Sarah, now 16 years old, was reunited with her mother and grandmother. Together, they chose to re-enter the Empowering Families program.

Elvia has been working with this three-generation family for several months, and helped connect Sarah to the Department of Mental Health to receive the treatment she needs. Sarah is



now enrolled in school full-time and has a much happier outlook on life. Elvia has also assisted Sarah's mother and grandmother with building additional protective factors for the family and accessing affordable healthcare.


Elvia and the other highly-trained caseworkers at Hope Center for Children make it possible for families like Sarah's to accomplish their goals.

# The Gift of Time: A Volunteer Story

In 2015, Olya eagerly began to volunteer at Faucette House, Hope Center for Children's emergency shelter. On her first day, she was a bit nervous, but the feeling quickly vanished as she was greeted with a big hug from a little girl. Now Miss O, as she is affectionately called by the kids, has been with us for a year and a half. "You do it because you want to help the kids, but then they're actually the ones that really help you," she reflected.

When Olya is volunteering, she spends her time focused on the kids, making sure they have all that they need and feeling joy when they excel at whatever they do. She has love for every child she interacts with. With our nursery children, she quickly takes her hair down and lets them brush and braid it. With the teens, she is willing to help out with their chores, and with staff, she is flexible when we must cater to the needs of a child's behavior. She is one of our most caring volunteers, and Hope Center for Children recently recognized her with the MLK Drum Major For Service Award.

Olya has lived in and loved Spartanburg ever since she was adopted at the age of 7. Currently, she is majoring in Psychology at USC Upstate and even picked

Services


