# Parenting? You've got this!

Amanda is a stay-at-home mom who was feeling stressed by having two pre-schoolers at home and a first grader. Additionally, Amanda and her husband were often frustrated by their different parenting and discipline approaches.

With a goal of getting control of the her 3 year old's behavior while also giving equal attention to her older children, Amanda registered for a Triple P (Positive Parenting Program) session. "I could hear the stress in Amanda's voice when she called, and I am pleased to have been able to connect her to a practitioner close to her home," shared Angela Talley Robinson, the Director of the Triple P Expansion.

After completing the four onehour seminars, Amanda felt motivated to begin applying Triple P's suggested practices right away. Amanda shared that she began seeing an improvement in her child's behavior almost immediately! After also feeling a difference in the way she and her husband were able to provide consistent instruction and age-appropriate discipline, Amanda registered for 2 more



Triple P seminars to learn more.

Amanda shared that the new parenting style has calmed both her and her child, improved her relationship with her husband, and both feel a stronger bond to all three children.

# **Chasing the Dream**

When Amy arrived on Hope Center for Children's campus, she was struggling with behavior problems and poor academic performance. She was constantly in trouble at school, receiving multiple suspensions, making academic success seem far out of reach. She had no plans for her future. College seemed like a far off fantasy she thought she could never achieve.

Then, something changed. Amy began participating in house activities with the other Anchor House girls, learning responsibilities and working through challenges. She set academic goals and worked hard to reach them. Amy gained more independence and became a role model for the other Anchor House residents.

For the first time, Amy had goals for her future, and she was determined to reach them. College was the ultimate dream. She applied for and received a scholarship from the Ellen Hines Smith Scholarship Fund that is available to all current and past residents. She also worked a full-time job, saving everything she could for college expenses.

Amy waited patiently for her acceptance letter to come. Months went by with no news. She had nearly lost all hope. She had worked so



hard and made great changes in her life. The Anchor House staff were puzzled as well, until one of them made a phone call to admissions. It turns out, the acceptance letter was misplaced on someone's desk all along. Amy and the staff were overjoyed to learn she had been accepted into college.

It has been a bittersweet transition since Amy moved into her dorm room and began the college future she had worked so hard for. The Anchor House residents still look to Amy as an example of someone who worked extremely hard and accomplished her goals.

All of us at HCFC are grateful for the community of supporters who further our mission, allowing children like Amy to chase their dreams!






#### **2017 Audited Expenses**



#### **Expenses by Program**




